Annamalai University

In the early 1920s, to serve the downtrodden and to promote Tamil Literature, Rajah Sir S.R.M. Annamalai Chettiar founded Sri Minakshi College and Sri Minakshi Tamil College at Chidambaram. In 1928, Rajah Sir S. R. M. Annamalai Chettiar agreed with the local Government to handover the above said institution for establishing a University. Thus, on 01.01.1929 Annamalai University was established as per Annamalai University Act 1928 (Tamil Nadu Act 1 of 1929) amidst a rural environment serving all the disadvantaged districts of Tamil Nadu.

Subsequently, Annamalai University Act, 2013 (Tamil Nadu Act 20 of 2013), came into force from September 25, 2013, after obtaining the assent of His Excellency, the President of India. The Act of 2013 has been amended by enactment of Act No. 32 of 2021 to render the University as an affiliating University. Consequently the Colleges situated in the districts of Villupuram, Cuddalore, Kallakurichi and Mayiladuthurai have been affiliated to Annamalai University.

Accolades

Annamalai University, accredited with 'A+' Grade (3.38 CGPA) by **NAAC** in 2022, is one of India's largest public residential universities with 8 Faculties and 57 departments/centres/divisions of study. Sprawling over 950 Acres of land, the University does yeoman service in taking education to the door steps of the people who are otherwise far from access to centres of higher learning. The University has initiated several innovative teaching programmes over the years that are progressive and human resource centric; offering 'current-cum-next-gen' academic and research programmes that are global and national in character. A systematic introduction of Learning Outcome Based Curricula (LOBE) that bear remarkable relevance to the UNO's Sustainable Development Goals (SDG) is the hall mark of Universities Curriculum design. Besides, Annamalai University has been a pioneer in distance education.

I. FACULTY OF AGRICULTURE

The Faculty of Agriculture was started in the year 1958. Presently there are nine departments in this faculty namely, Agronomy, Entomology, Plant Pathology, Agricultural Microbiology, Soil Science and Agricultural Chemistry, Genetics and Plant Breeding, Horticulture, Agricultural Economics, Agricultural Extension Education and Division of Animal Husbandry.

Quality and Excellence in Teaching

- i. The Faculty offers facilities such as Hi-tech class room with LCD projectors and internet connectivity, well established Experimental farm, Sewage farm, Agro-Meteorological observatory, Automatic weather station, Orchard, Livestock farm and an air conditioned seminar hall.
- ii. Hands-on-training in scientific Agricultural and Horticultural techniques and analytical skills are taught to students.
- iii. State-of-art knowledge in wider disciplines of Agriculture are being imparted to the students to meet the global challenges.
- iv. Training programmes to take up commercial Agriculture is an integrated component of curriculum.
- v. Exposure to motivational events for students to make them job providers rather than job seekers.
- vi. Experiential Learning and Rural Agricultural Work Experience is introduced in the curriculum to offer scope for participatory and bottom up approaches of learning process.

Research Facilities

The grants obtained from UGC, DST, DBT, ICAR, NMPB, Ministry of Coal, Ministry of Environment and Forests, Ministry of Water Resources, TANSCH, etc. and budgetary provision from the University have added to an excellent infrastructural setup that facilitate cutting edge research in Agriculture and Horticulture.

Teaching, research and extension activities, the three vital components for any Agricultural institution, add significant value to the Faculty of Agriculture. The research and extension activities of the Faculty of Agriculture have clearly made significant strides in improving the life style of the farming community and enhancing the caliber and aptitudes of agricultural graduates.

- A.** A candidate shall apply for **only three subjects** in Masters programmes. **Separate fee is to be remitted for each subject.**
- B.** All applicants should fill in the applications by **ONLINE ONLY** (<https://admissionsatpgschool.tnau.ac.in/>) till **12.00 midnight on or before** for **Masters programmes.**

The candidates seeking admission against differently abled set apart for Hearing impaired /Orthopedically Differently Abled / Visually Impaired **should produce the recent certificate from the Medical Board of the District** concerned certifying the nature and extent of disability in percentage. **Certificates obtained from an individual Doctor will not be considered and such applications will be summarily rejected.** Further, a separate TNAU Medical Team will examine the candidates with reference to their certificates and his/her suitability for admission to TNAU (Refer: **Appendix-I**)
- v. A scanned copy of Provisional / Degree certificate showing the Class or OGPA obtained in the qualifying degree.
- vi. Scanned copies of Mark list / Transcript card showing details of courses undergone and marks obtained in the qualifying degree.
- vii. While submitting the applications by online, if required scanned copies (documents) are not uploaded, then the application will summarily be rejected without any intimation.

2.3 Hostel Fee

Annamalai University is a residential University. Adequate hostel accommodation is available. Candidates are advised to stay in the Hostel. The room rent and establishment charges are as given below:

This fee will cover room rent, electricity & water charges, establishment and miscellaneous charges only. The mess fees of Rs.27,000/- will be adjusted from their scholarship amount received from SC/ST Post Metric Scholarship and Higher Education Special Scholarship. If the scholarship amount received is less than Rs.27,000/- the balance amount should be paid by the students.

2.4 Scholarships

The students of Annamalai University can avail the Government Scholarships subject to eligibility.

- i. **Application Fee Concession to SC/ST and Converted Christian Students:** Entrance/ Course application fees concession is granted to students belonging to SC/ST Community and Converted Christian by the Government Tamil Nadu (G.O. No. 111. 22.09.1998).
- ii. **Tuition Fee Concession to SC/ST and Converted Christian Students:** Full tuition fee concession is granted to students belonging to SC/ST community and converted Christian under the rule 92 of Tamil Nadu Education Rules by the Government of Tamil Nadu [92-TNER].
- iii. **SC/ST Community students** whose parent's/guardian's income from all sources should **not exceed ₹ 2,50,000/- per annum and Converted Christian (converted from SC/ST) ₹ 2,00,000/- per annum.**
- iv. **Other State Scholarship:**
 1. **Other State Scholarships** for SC/ST/BC/OBC/MBC students.
 2. **Puducherry State Scholarships only for Puducherry SC/ST Students.**
 3. **"ISHAN UDAY" Scholarship for Northern Eastern Region Students.**
- v. **Minority Scholarship:** Minority Scholarship award on the basis of merit cum means for minority community students.
- vi. **Higher Education Special Scholarship:** In addition to the Post Metric Scholarship, Higher Education Special Scholarship is awarded to the hostel students belonging to SC/ST and Converted Christian community and the number of scholarships is limited by the Government. The annual income from all sources **should not exceed ₹ 2,50,000/- per annum.**
- vii. **BC/MBC/DNC Scholarship:** The scholarship will be awarded to the students belonging to **BC/MBC/DNC** communities whose parent's/ guardian's income from **all sources should not exceed ₹ 2,00,000/- per annum.**
- viii. **Fee Concession to Blind Students:** Under rule 92 (TNER), full tuition fees concession is granted to blind students belonging to all communities whose parent's/Guardian's annual Income **from all sources should not exceed ₹ 2,50,000/-.**

B. Note: For all Scholarships Income Certificate taken after April 2024 should be produced.

- i. UGC scheme for award of Post Graduate Scholarship for Professional Courses for SC/ST Candidates.
- ii. **Post Graduate Indira Gandhi Scholarship for single girl child:** This is only for the candidate who happens to be a single girl child of the family (having no brother or sister) and who has taken admission in regular full time Master Degree course in recognised University or a Post Graduate College in conventional basic subject.

III. ELIGIBILITY CRITERIA

3.1. Qualifying Examinations and Eligibility Masters programmes

Only those students who have studied in State Agricultural Universities (SAUs)/ Colleges affiliated to SAUs/ Central Agricultural Universities (CAUs)/ ICAR Deemed Universities/ Central Universities with Agriculture Faculty listed by ICAR/ any other institutes accredited by NAEAB (ICAR) alone are eligible for admission to TNAU for Masters Programmes of the University.

MINIMUM OGPA /AGGREGATE REQUIREMENT

Masters Programme: A candidate who has undergone course credit system with a **minimum OGPA of 3.00 out of 4.00 or 6.60 out of 10.00 in Bachelor's Degree Programme** can apply for Masters Programme. However, **for SC/ST candidates, minimum OGPA of 6.50 out of 10.00 in bachelor's degree** is sufficient.

Masters programme:

Graduates who have successfully completed four-year undergraduate degree programme (specified below) and awarded by any one of the State Agricultural Universities (SAUs)/ Colleges affiliated to SAUs/Central Agricultural Universities (CAUs)/ ICAR Deemed Universities/ Central Universities with Agriculture Faculty listed by ICAR/ any other Institutes accredited by NAEAB (ICAR) alone are eligible to apply for Masters programme.

IV.ALLOCATION OF SEATS**Reservation of Seats**

Reservation of seats for candidates belonging to ST/ SC/ SCA/ MBC/ DNC/ BC/ BCM/ OC communities will be made as per rules and regulations of the Government of Tamil Nadu.

Tamil Nadu Ordinance No. 4 of 2007 published in the Tamil Nadu Government Gazette Extraordinary No. 262 dt. 15.09.2007 provides for reservation in respect of annual permitted strength in each branch or faculty for admission into educational institutions in the State including private educational institutions. For the Backward Class Muslims, it shall be three and a half per cent within the thirty per cent reservation for Backward Class as provided in the 1994 Act and in 2006 Act.

- * G.O.Ms. No.28 dated 06.04.2015 (Inclusion of Transgender / Eunuch (Thirunangai / Aravani) in the list of Most Backward Classes)
- ** G.O. Ms. No. 50, Adi Dravidar and Tribal Welfare (TD-2) 29.04.2009. (16% seat offered to Arunthathiyars within the seats reserved for scheduled castes towards admission in Educational Institutions).
- Five per cent of the seats of M.Sc. degree programmes are reserved for differently abled candidates (Hearing impaired; Orthopaedically Differently abled and visually impaired).

It was published that persons with only locomotor disability (lower limb) are eligible to apply to TNAU and Annamalai University (pages 22 and 23 of the information brochure hosted in <https://tnagfi.ucanapply.com>). Based on the guidelines of the Government of Tamil Nadu, now it has been revised that applicants with locomotor disability, low vision, hearing impairment, cerebral palsy and specific learning disability are considered eligible to apply to TNAU and AU. At the time of certificate verification and counselling, the eligibility for admission will be decided by the medical team based on functional requirements. Otherwise, all the eligibility requirements and relaxation for the differently-abled applicants laid in the brochure hold good.

V. MODE OF SELECTION

A candidate should apply separately for aided and self supporting programmes in which he/she can indicate three choices of courses in his/her order of preference. The selection will be based on an entrance test and subsequent counseling process.

Eligible candidates will write the entrance test for 100 marks in three compartments.

Compartment 1	General Agriculture	For 15 marks
Compartment 2	Aptitude	For 10 marks

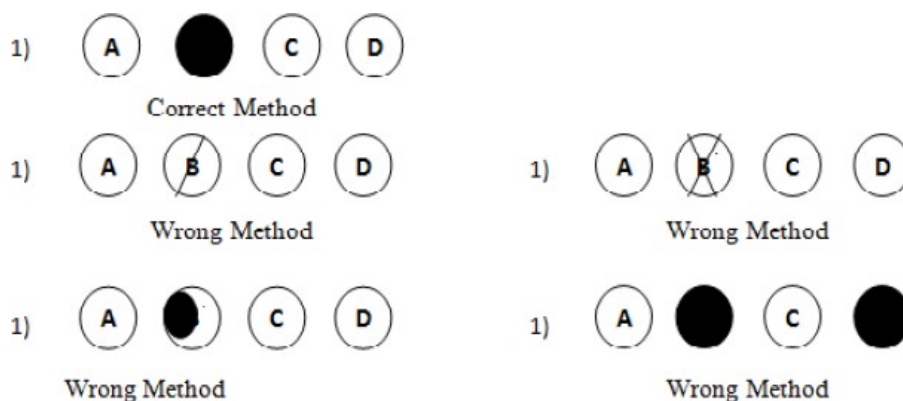
Candidate should write the entrance exam for all the courses of his/her choice continuously on the same day. Candidate shall be required to be present on the specified date for **a written test and interview at their own expenses. Date of the entrance test and counseling will be informed later.**

5.1 General Instructions for Entrance Test are as follows.

1. A valid photo I.D proof in original is required for entering entrance hall. Candidates arriving late by more than half an hour from the start of the examination will not be permitted to write the test.
2. Calculator, log tables, pager, mobile phone/Bluetooth devices or any electronic gadget, notebook or written notes, pamphlets, slide rules, protractors, rulers, highlighters, dictionary, electronic watches etc. are not allowed inside the Examination Hall. Any violation would amount to disqualification of candidature.
3. Any candidate, who creates disturbance of any kind during the Test or otherwise misbehaves in or around the Examination Centre or changes his/her seat with any candidate will be expelled from the Exam Hall and it amounts to disqualification of the candidate.
4. Any candidate having in his/her possession or accessible to him/her papers/books or notes which may possibly be for providing assistance or copying from any paper/book or note or allowing any other candidate to copy from his/her answer sheet or found writing on any other paper, or using or attempting to use any other unfair means will be expelled from the Exam Hall.
5. The decision of the University to expel a candidate from the examination centre will be final.
6. If a candidate puts any identification mark on the Optical Mark Recognition (OMR) sheet, the same is liable for cancellation. The decision of the University in this regard will be final.
7. If impersonation in the Entrance Test is detected, the candidature will be cancelled, and a case will be registered with the police.

5.2 Instructions for Answering through OMR Sheet

1. Read the instructions carefully given on the question paper.
2. Write your registration number only in the space provided on the question paper and OMR sheet and nowhere else.
3. The candidates are required to follow the correct procedure while answering the question paper. Shade the circle pertaining to the most appropriate answer on the OMR sheet with **black ball point pen**. If more than one circle is shaded, the answer will be treated as wrong. Incorrect marking will also be taken as wrong answer. For example, if you think that the answer given against choice (B) for question number 1 is the most appropriate answer, then shade the circle (B) given against 1.



4. Do not use any other mark except shading the circle.
5. The candidates will not be allowed to leave the examination hall within the first 45 minutes of start of the examination.
6. There will be no re-evaluation of the answer sheets.
7. Candidates must bring two ball point pens of black colour.
- 5.3 All the original certificates for which scanned copies have been uploaded while filling online application should be submitted during admission without fail. Candidates who fail to upload certificates will not be allowed to appear in the entrance test and the application will be rejected.
- 5.4 Candidates should upload Provisional Certificate or Degree certificate or Course Completion from Registrar/ Controller of Examinations/ Dean of the University authorized signatory without which they will not be permitted to appear in the examination. The decision of the Chairman of the Admission Committee is final in this regard.
- 5.5 Allotment of students to the Constituent Colleges (for course and thesis work) of Tamil Nadu Agricultural University will be based on the merit. The decision of the University will be final in this regard. Any recommendations shall be viewed seriously.
- 5.6 Submission of Degree Certificate/ Provisional Degree Certificate is must at the time of admission. Failing which the candidature will be cancelled even if he/she has passed the TNAU Entrance Examination.

VI. CODE OF CONDUCT

The following code of conduct shall be observed by the students who are admitted.

- i. The students should conduct themselves in an exemplary manner so as to be model for other students.
- ii. All students will have to strictly adhere to the rules and regulations of the University.
- iii. RAGGING: The candidates should not indulge or participate in any kind of ragging. If they are found to have indulged in ragging in the past, or noticed later, the candidates will be removed

from the roll of the institution at whatever stage of study and criminal action will be taken against the candidates.

- iv. If any student is involved in ragging or any other anti- social activities, he/she will be expelled and criminal proceedings will be initiated against him/her.**
- v. The students should be present during all working days and be sincere to studies.
- vi. The students should attend the classes regularly, punctually and fulfill the minimum of 75% attendance requirement as prescribed by the University, to be eligible for appearance in the University Examinations.
- vii. The campus is "Tobacco Free" and "Liquor Free". Any violation of this will result in dismissal from the program.
- viii. Use of mobile phones and other electronic gadgets are not permitted in the class rooms, examination halls, faculty premises, university organized functions / programs/ extracurricular and co-curricular activities.
- ix. The students are forbidden from using motorized vehicles, including powered two wheelers inside the campus.
- x. Dress Code: Students need to wear formal dress largely covering them like Sarees/ Churidhar with dupatta for ladies and Pant and Shirt for men.

7.1. Application

Separate Online Application should be submitted for Aided and Self-Supporting programmes in which candidate can indicate three courses of his/her choice in the order of his/her preference, Procedure for registration of application is online from the University website: www.annamalaiuniversity.ac.in/adm

7.2 General Instructions for applicants

The candidate will be informed of their selection for admission to P.G. programme by **email** or **SMS only**. List of selected candidates will be hosted on the University website also. **University will not be held for any responsibility towards failure in the delivery of e-mails or SMS.** The selected candidate should pay the prescribed fee on or before the date specified by the Dean, School of Post Graduate Studies, failing which their names will be removed from the selection list and the resultant vacancies will be filled up from the wait list.

7.3 The following original documents must be surrendered at the time of admission and failure to surrender any of the documents will make the candidates ineligible for admission.

- i. Provisional / Degree certificate of Bachelor's programme.
- ii. Transfer / Migration certificate.
- iii. Conduct certificates: one from the Head of the Institution and two from the Professors of the Institution where the candidate last studied.
- iv. Mark list/Transcript card of Bachelor's degree.

- v. The original Community Certificate issued by the competent Revenue authorities should be produced for verification. **An attested copy of original community certificate should be submitted for record.**

- vi. A copy of the online fee payment receipt.

Candidates who have paid the fee should register their courses on the date specified or within seven working days (inclusive of Saturdays) from the commencement of semester failing which the candidates will have to forfeit their admission.

Selected candidates who pay the fee on the notified date but fail to register on the specified date or fail to inform within seven working days from the date specified for registration are liable to forfeit all fee paid.

Candidates who discontinue after admission (or) registering the courses are not eligible for refund of any other fees except caution money deposit.

All originals are to be produced at the time of interview/admission.

Online Application filled for one programme cannot be transferred to another programme.

Original Certificates submitted at the time of admission will be returned before the end of second semester. In case a candidate requires the original certificates for valid reasons, he/she may apply for the same with valid proof. The candidates are advised to have with them attested copies of mark lists or other certificates that may be required for applying scholarships/ bank loan etc.

7.4 Important Conditions for Applicants

- i. Tuition fee for each academic year should be paid well before the due date, failing which a fine as prescribed by the University will be charged. The candidate shall not be permitted to appear for the University Examination without clearing the Tuition fee arrears.
- ii. Tuition fee for the entire programme together with arrears, if any, shall be payable by the student before Transfer Certificate is issued.
- iii. Special fee for the remaining period of programme shall be waived.
- iv. No certificate will be issued, unless the candidate has cleared all the arrears of fees etc., due to the University.
- v. Caution deposit shall be refunded on application after adjustment towards any dues from the student. Application for refund of caution deposit should be submitted within one year of completing the course.
- vi. With regard to any dispute arising in relation to admission, examinations, remittance of fees, etc., the place of jurisdiction for the purpose of filing a suit or preferring a complaint or taking any legal proceedings against the University, will be Chidambaram Town only.
- vii. Students discontinuing the programme before commencement of classes are eligible to get full refund (except service charges ₹ 1,000/-).
- viii. Those who discontinue after commencement of classes are eligible to get refund of caution money deposit only.

- ix. The candidates who have joined a programme and wish to discontinue, should pay the tuition fee in full up to the year of study.

7.5 General Information

The following procedures should be followed for applying/getting certificates viz. Bonafide / Course completion/Mark lists etc. with the fee prescribed by the University.

- i. **General:** Mark list for each Semester/Year during the period of study will be issued by the University and distributed through the respective departments of study. On completion of the program, Provisional Certificate and Transfer Certificate will also be distributed through the department concerned.
- ii. **Migration Certificate:** This certificate will be issued by the University Office ('K' Section) only on demand to those who have planned to undergo higher studies in any Educational Institution in India.
- iii. **Duplicate Certificate - Mark List / Degree / Transfer Certificate:** A certificate from the police department is required to be produced for the loss of certificates indicating that the certificates were actually lost beyond recovery.
- iv. **Degree Certificate:** Notification will be issued in the leading dailies as well as in the University website during the month of September/October every year inviting application forms for obtaining Degree Certificate at the Convocation. Students shall apply for the same in the prescribed form which can be obtained from the University.
- v. **Personal File:** Students are advised to maintain a personal file containing all academic records such as challan for remittance of tuition fee, exam fee, instrument fee, condonation fee etc. till completion of his/her studies.
- vi. **Re-admission:** If any attendance deficiency during the tenure of his/her studies, candidates shall apply for re-admission through the Heads concerned along with the photocopy of his/her previous semester/year mark list(s) as proof for having appeared for the University Examinations.
- vii. **Change of Name/Date of Birth:** Candidate who wishes to change the Name, Date of Birth, of his/her name should be made only during the period of study by producing a copy of "Gazette Notification" from the respective Government No. such change shall be entertained after completion for his/her studies in the University.
- viii. **How to get Certificate:**
 - a) Students may apply for any certificates in this University viz., Duplicate mark list, Degree Certificate and Transfer Certificate etc, either during the tenure of his/her studies on completion of the program and may obtain the same from the office or by post within a fortnight period from the date of filing application in the office. He/she should possess compulsorily **1)** a copy of letter where he/she has applied for **2)** a copy of remittance challan and **3)** any other documents, whenever any lapse of the original submitted to University (or) loss in transaction.

- b) If candidates do not receive the certificate/s within the stipulated period, then he/she can immediately seek the assistance of the Section Head/Deputy Registrar of the 'K' Section with relevant copy of records that has been already submitted for claiming the certificates, so as to enable them to get the certificate from the office (or) necessary guidance will be provided for the same.
- c) Students admitted to various programs of the University, should get back his/her original certificates produced at the time of admission within three months either on completion of program (or) discontinuing the same in the middle of the program. The University is not responsible for any lapse or damage of the certificates, beyond this period.
