- *The article should be an original contribution and in English*
- *Title should be in bold letters not exceeding 15 words*
- *The length of the paper should not exceed 5000 words*
- *The paper should be neatly typed and in word format*
- *The Abstract with 300 words and 5 key words is compulsory*
- *Font – Times New Roman, 12 , A4 size paper with standard margin of 1 inch on all sides.*
- *The author(s)'s name, designation and affiliation should be typed after the title of the article and should include email address*
- *Graphs, figures, photos and tables should be placed in the text wherever they are discussed in the paper*
- *For references APA format 6th edition to be adopted*
- *Plagiarism of any type to be strictly avoided*
- *The contributors will be informed about the acceptance after the review process is over*
- *Not more than 2 authors are allowed for a book chapter*
- *If the chapter sent is not relevant to any of the subthemes mentioned, the editor can reject the chapter, and the amount will not be refunded.*
- *The acceptance of the paper will be informed within 20 days of the receipt of the chapter*

Each author has to pay the prescribed fee for the publication

The Paper/ Article will be published in a ISBN numbered book, and the contributor will receive a soft copy of the book for which a sum of Rs.1500/- will be charged.
